RELEASE WAIVER

As an owner, **student, contestant, exhibitor, spectator, volunteer, employee, independent contractor or parent**, I the undersigned, recognize that all equestrian-related activities may be **extremely dangerous**, that accidents involving horses and contestants are frequent, that the condition of the land is **hazardous** and that ring or arena footing is rarely perfect. In light of this knowledge, **I assume and undertake full responsibility for all risk**, inherent in all horse related and livestock related activities, including but not limited to bodily injury and physical harm to horse, rider and spectator.

In consideration, therefore, for the privilege of riding and/or working around horses and/or livestock or being a owner, student, contestant, exhibitor, spectator, volunteer, employee, independent contractor or parent at or on the property hereinafter referred as **(Triple Take Arena Boarding and Event Center)** from the undersigned, with full knowledge of the potential danger and risks, hereby releases **Triple Take Arena Boarding and Event Center** from any and all liability for horse or rider. Losses occasioned by the injury or death of rider, owner, student, contestant, exhibitor, spectator, volunteer, employee, independent contractor, parent or horse are agreed to be covered by the undersigned or the insurance of the undersigned and it is further agreed that the undersigned's heirs, representatives, dependents or guests shall have no right or action against **Triple Take Arena Boarding and Event Center** or its owners and employees, independent contractors, it's invitees, or any of **Triple Take Arena Boarding and Event Center** Insurance carriers.

If the person is under 18 years of age, signature of the parent or guardian indicates acceptance of responsibility by said parent or guardian and release of liability of **Triple Take Arena Boarding and Event Center** and affiliated persons.

If damage is caused by or to the undersigned's horse or horses (including but not limited to, escape from enclosures), the undersigned takes full responsibility for damages to persons, property, or other horses and agrees to indemnify **Triple Take Arena Boarding and Event Center** and its owners and employees against liability for such damages.

The undersigned further agrees to indemnify **Triple Take Arena Boarding and Event Center** for any liability for physical loss or injury, or damage causing death, or making destruction necessary to horse or horses in **Hay Shed Arena**, care.

It is understood and agreed that **Triple Take Arena Boarding and Event Center** assumes no responsibility for personal property of the horse owner and said property is stored on the premises at the sole risk of horse owner.

This indemnity Agreement shall cover all uses of the facilities of **Triple Take Arena Boarding and Event Center** by the Undersigned until revoked in writing by the Undersigned.
